## Introduction

Our company, France Télévisions Publicité (hereinafter "**We**"), is an advertising network whose activity involves marketing advertising space to Advertisers on Media published by third parties.

To do this, We approach Advertisers to offer them the opportunity to broadcast their advertising, either based on the context of the Media concerned (for example, a sports website may have a football section, a golf section, etc.), or according to a Segment with which You are affiliated.

In the latter case, We try to direct advertising to You based on Your preferences, which are determined using Your Personal Data and, where applicable, its aggregation. Your Personal Data is collected under the conditions detailed in paragraph 3 of this Privacy Policy.

France Télévisions Publicité is the advertising network for several Publishers, including France Télévisions. These Publishers refer to us by name in their privacy policy.

You have the right to object at any time to the processing of Your Personal Data for advertising purposes.

In order to do so, We have detailed the procedure to follow here.

### 2. Definitions

For the purposes of this Privacy Policy, We will use the following definitions:

<b>Advertiser</b>	Refers to a natural or legal person who wishes to broadcast advertising space on the Media in order to promote its products or services, where applicable through intermediaries (e.g. advertising agencies). The Advertiser is the corporate sponsor of a campaign;
<b>AdServer</b>	Refers to a technological platform that ensures the broadcast of advertisements on the Media. It can be used to target certain Segments and to monitor campaigns by providing statistics and indicators (capping, volumes, dates, metrics, effectiveness, click rates, etc.);
<b>Trackers</b>	Refers, in accordance with the Personal Data Regulations, to a sequence of information, generally small and identified by name, that may be transmitted to Your Terminal by Us or by one of our Technical Partners from a Medium to which You connect. Your Terminal will store this information for a certain period of time, and will send it back to Us or to one of our Technical Partners every time You connect to a Medium. Trackers have multiple uses and can be used to store: your customer username on a retail site; the current contents of your shopping cart; an identifier to track your browsing for statistical or advertising purposes, etc. The term "Tracker" in this Privacy Policy refers to trackers and/or equivalent technologies,

	such as cookies, Flash cookies, local web storage, web beacons, etc., in accordance with the Personal Data Regulations;
<b>Data Management Platform or DMP</b>	Refers to the technological platform enabling the collection of different sources of Personal Data for the purpose of enriching it, and establishing and activating Segments to carry out targeted advertising campaigns;
<b>Demand Side Platform or DSP</b>	Refers to a technological platform that enables the automated purchase in real time, impression-by-impression, of advertising space on the Media, offered by the different SSPs to which the DSP is connected;
<b>Personal Data</b>	Refers to Your personal data, as defined in the Personal Data Regulations, processed by France Télévisions Publicité for the purposes set out in Article 7 of the present Privacy Policy;
<b>Publisher</b>	Refers to the publisher of a Media partner of France Télévisions Publicité;
<b>France Télévisions Publicité, We, Our</b>	Refers to the public limited company ( <i>société anonyme</i> ) with a Board of Directors and capital of 414,308,800.00 euros, whose head office is located at 64 Avenue Jean Baptiste Clément, 92100 Boulogne Billancourt, registered with the Nanterre Trade and Companies Register under number 332 050 038;
<b>Partners</b>	Refers to both our Data Partners and our Technical Partners;
<b>Data Partners</b>	Refers to Our Partners, including Publishers and/or Technical Partners, who pass on to Us some of Your Personal Data collected by them or through their own partners in accordance with the Personal Data Regulations;
<b>Technical Partners</b>	Refers to Our service providers who are mainly involved in the provision of technology services;
<b>Privacy Policy</b>	Refers to the present document setting out Our policy for the protection of Your Personal Data, implemented by France Télévisions Publicité;
<b>Personal Data Regulations</b>	<p>Refers in particular to:</p> <ul style="list-style-type: none"> <li>• Directive 2002/58/EC of 12 July 2002 concerning the processing of personal data and the protection of privacy in the electronic communications sector, as amended by Directive 2009/136/EC of 25 November 2009, commonly referred to as the "<b>ePrivacy Directive</b>";</li> <li>• Act No. 78-17 of 6 January 1978 relating to data processing, files and liberties, as amended in its latest version by Act No. 2018-493 of 20 June 2018 relating to the protection of personal data and commonly referred to as the "<b>French Data Protection Act</b>";</li> <li>• Deliberation No. 2019-093 of 4 July 2019 adopting guidelines relating to the application of Article 82 of the Act of 6 January 1978 as amended to reading and writing operations in a user's terminal (including cookies and other trackers), commonly referred to as the "<b>Recommendation on cookies and other trackers</b>";</li> <li>• Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and the free flow of such data, commonly referred to as the General Data Protection Regulation or "<b>GDPR</b>";</li> </ul>

<b>Segment</b>	Refers to a category of Data Subjects (as defined below) determined on the basis of common characteristics defined in advance by Us or one of Our Partners (see paragraph 7);
<b>Supply-Side Platform or SSP</b>	Refers to a technological platform that makes it possible to optimize and automate the sale of advertising space on its Media by enabling said advertising space to be targeted to certain Segments;
<b>Medium/Media</b>	Refers to any medium for broadcasting advertising spaces on which Advertisers' advertisements are displayed. For example (non-exhaustive list): a Publisher's website, Your TV before watching a France Télévisions program on-demand, a mobile application consulted via Your Terminal;
<b>Terminal</b>	Refers, in accordance with Directive 2008/63/EC, to the hardware equipment (computer, tablet, smartphone, phone, connected TV, etc.) used by You to consult or view a Medium;
<b>You (Your) or Data Subject</b>	Refers to the natural person whose Personal Data is processed.

Your Personal Data is not directly identifiable. We do not collect Your first or last name, or even Your mailing address, nor Your material identifiers (UDID or MAC).

We do not collect sensitive Personal Data as defined by the Personal Data Regulations such as Personal Data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs or trade union membership, or concerning the health, sexual activity or sexual orientation of the Data Subject.

The only link with Your Personal Data is one or more unique identifiers that may include: a pseudonymized IP address, a Tracker number on one of Your Terminals or the advertising identifier of Your Terminal.

### 3. Source of Personal Data Collection

We collect Personal Data concerning You via Our Data Partners (see paragraph 3.1) and with the help of Trackers that we place on your Terminal using certain compatible Publishers' Media.

#### 3.1. Personal Data collected from our Data Partners

Our Data Partners provide us with Personal Data about You, on the condition that it has been collected in accordance with the Personal Data Regulations.

We refuse to acquire Personal Data: (i) that has not been collected and processed in a lawful, fair and transparent manner with respect to You; (ii) that has been collected for purposes that are not determined, non-explicit and/or not legitimate, in particular with respect to their advertising purpose; or (iii) that is not appropriate, relevant and limited to what is necessary for the advertising purpose for which it is intended to be processed.

The Personal Data communicated by Our Partners is of three types, namely: i) that which You declare on a form on one of the Partners' Media or related to Your interaction with this Partner (purchases, claims, requests, etc.); ii) that which the Partners collect using their own Trackers; iii) and that which has been collected by their own partners, always in compliance with the Personal Data Regulations.

### **3.2. Personal Data collected by our Partners' Trackers**

When consulting the Media of one of Our Partner Publishers, Personal Data, indicated in Article 4, may be collected by our Partners' Trackers, subject to Your consent.

These Trackers enable the collection of Your Personal Data, notably in relation to Your browsing.

Our Partners' Trackers have a maximum lifespan of thirteen (13) months.

## **4. What Personal Data is collected?**

The Personal Data we collect is as follows, depending on the Medium from which the Personal Data was collected:

- Your age range and gender when You provide them to a Partner Publisher.
- Your location data when You provide a Partner Publisher with Your postal code.

Your location data may also be determined from Your IP address, collected by the Publisher or by one of the Trackers or from Your Terminal subject to Your prior consent.

- Your browsing data is collected by the Trackers or by Our Data Partners, including in particular: the Media consulted and, more precisely, sections visited, videos viewed, etc.
- Our Data Partners may also communicate Segments to Us based on Your browsing, Your purchase intentions and/or Your preferences observed on third party media.

## **5. Legal basis for the collection and Processing of Your Personal Data.**

### **5.1. Legal basis for the collection of Your Personal Data by means of Trackers**

In accordance with the Personal Data Regulations, in particular the e-Privacy Directive, the French Data Protection Act (Articles 8-I-2b and 82), and the Recommendation on cookies and other trackers, We require that the Publishers with whom We are partners ensure that the Trackers obtain Your Consent and cannot be stored or read on Your Terminal until You have given Your consent.

More specifically, when You go to a Publisher's Medium, You are regularly informed, and always during Your first visit, by the appearance of a consent banner:

- (i) Of the identity of the data controller(s);
- (ii) Of the precise purposes of the Trackers used on the Digital Medium;
- (iii) Of Your right and ability to object, at any time, to the placement of these Trackers on Your Terminal, using a dedicated button after clicking on a link in the consent banner;

In accordance with the Personal Data Regulations, this consent banner may disappear as soon as You give Your consent, i.e. by a positive action on Your part, unless You refuse the storage of Trackers.

We require Publishers to inform You in a simple and intelligible manner of the solutions available to You in order to accept or refuse Trackers, both via the consent banner and via the Publisher's Privacy Policy, and that user-friendly solutions are put in place to enable You to withdraw Your consent as easily as You gave it.

Similarly, We ensure that You are able to withdraw Your consent at any time via the Publisher's Privacy Policy.

If You refuse a Tracker, You can still continue to use the Medium. However, this refusal does not forbid Us from directing advertising to You that is not personalized based on Your browsing or Your preferences.

The period of validity of Your consent to the storage of Trackers is extended to a maximum of thirteen (13) months. At the end of this period, Your consent will have to be obtained again by the Publisher in the forms mentioned above.

The same requirements apply to Partners who send us Personal Data that they have collected independently through third party Trackers.

## **5.2. Legal basis for the collection of Your Personal Data other than by Trackers**

In accordance with the Personal Data Regulations, in particular the GDPR, we require Our Partners not to collect Your Personal Data, other than by means of Trackers, unless any of the following circumstances apply:

- You have given your consent under the conditions mentioned in 11) of Article 4 and Article 7 of the GDPR to the Processing of Your Personal Data for advertising purposes; (*e.g. You have ticked a box such as "I agree to receive offers from Partners of X"*)
- Processing for advertising purposes is necessary for the performance of a contract to which You are a party; (*e.g. You have voluntarily agreed to receive a free service in return for the use of Your Personal Data for advertising purposes.*)
- The fulfillment of the legitimate interest of the data controller or the recipient, provided that Your interest or Your fundamental rights and freedoms are not disregarded. (*e.g. A processing operation which serves an economic interest and enables the controller to offer a free and relevant service to its users, without disregarding the interests of their users and without violating their right to privacy.*)

## **5.3. Link with Our Data Partners**

We are not in direct contact with you.

Trackers are not stored via Media that we manage, but via Media operated by Our Data Partners, who are the only ones who can ensure that Your consent is obtained.

In the same way, the Personal Data that You enter on a Medium is the property of the Data Partners who publish this Medium.

Under these conditions, and although We regularly check Our Partners' Media, We can only invite You to notify Us of any Medium that You believe does not comply with the Personal Data Regulations, in order to enable Us to take the appropriate measures.

To contact Us, please use one of the methods outlined in paragraph 10.

## **6. How long your Personal Data is stored**

We keep Your Personal Data for a maximum period of thirteen (13) months.

## **7. Purposes of processing**

We process Your Personal Data in order to enable the broadcasting of "targeted" advertisements, adapted to one of the Segments to which You are attached.

For example, if You are interested in sports but do not enjoy cooking then we will try to send You sports-related advertising as a priority. Similarly, if You are a man, You may not want to receive advertising for women's fashion products.

Thus, when We receive a request from an Advertiser to send so-called "targeted" advertising, We select Segments and if the Advertiser is interested in them, We will then send them advertising, which will be visible when the Data Subjects belonging to these Segments visit the Media of one of Our Data Partners.

Please note that we do not disclose Your Personal Information to Advertisers, but only inform them of the common characteristics of the Segments to which we will address their advertising, e.g., "men", "women", "sports enthusiasts", etc.

We inform You that Advertisers are prohibited from including tracking methods in their advertisements on the Media without Your prior authorization.

Under these conditions, and although We regularly monitor Advertisers' advertising, We can only invite You to notify Us of any advertising that contravenes the aforementioned prohibition.

To contact Us, please use one of the methods outlined in paragraph 10.

Furthermore, when You click on an Advertiser's advertisement, it often directs You to a website operated by the Advertiser itself or one of its partners, who are free to place Trackers on Your Terminal in accordance with the Regulations and their own privacy policy.

## **8. Storage of Your Personal Data and its transfer, if applicable, to Technical Partners**

### **8.1. Where Your Personal Data is stored**

All useful precautions and all material, technical and organizational security measures have been taken to store Your Personal Data in a secure environment, through one of Our Technical Partners (the DMP), and to prevent it from being distorted, damaged or accessed by unauthorized third parties.

The DMP servers storing Your Personal Data are located in the United States.

The transfer of personal data to this country is governed by the following legal mechanisms: Standard Contractual Clauses.

### **8.2. Transferring Your Personal Data**

We may securely transfer some of Your Personal Data to Our Technical Partners to enable them to display advertising on the Media that You visit or to check their proper functioning.

Our relevant Technical Partners process Your Personal Data in accordance with the Personal Data Regulations but also in accordance with their own Privacy Policy.

If these Technical Partners store Your Personal Data outside the European Union, then We ensure that the transfer of Personal Data complies with the Personal Data Regulations, in particular Chapter V of the GDPR, and that it is bound by a specific guarantee (Privacy Shield, European Commission Standard Contract Clauses, etc.).

Among the Technical Service Providers concerned, Your Personal Data may be passed on to AdServers, SSPs, ISPs and Our DMP.

In accordance with their Privacy Policy, SSPs may disclose some of Your Personal Data to DSPs when they share information about a Medium on which advertising is to be broadcast.

You can ask us at any time for a list of our Technical and Commercial Partners by contacting our Data Protection Officer, whose contact details are in Article 1.

Finally, we may pass on Your Personal Data in response to an injunction from a competent judicial or administrative authority.

## **9. Your Rights**

In accordance with the Personal Data Regulations, You have the right to access, rectification, erasure, restriction, and portability, as well as the right to object to and define the processing of your Personal Data after your death (hereinafter Your "**Rights**").

### **9.1. Right to access**

You have the right to obtain confirmation from Us that Your Personal Data is or is not being processed and, when it is being processed, to have access to such Personal Data and the following information:

- the purposes of Processing;
- the Personal Data categories;
- the recipients or categories of recipients to whom the Personal Data has been or will be disclosed;
- where possible, the intended retention period of the Personal Data or, where this is not possible, the criteria used to determine this period;
- the existence of the right to request the rectification or erasure of Personal Data, or a restriction on the Processing of Your Personal Data, or the right to object to such Processing;
- the right to file a complaint with the CNIL;
- any available information regarding the source of the collection of Your Personal Data;
- the existence of any automated decision-making, including profiling, and, at least in such cases, any useful information regarding the underlying rationale, and the importance and anticipated consequences of such processing for You.

When Personal Data is transferred to a third country or to an international organization, You have the right to be informed of the appropriate safeguards with respect to such a transfer.

Following Your request, We provide You with a copy of the Personal Data being processed.

We may charge a reasonable fee based on administrative costs for any additional copies requested.

When You submit Your request electronically, the information is normally provided in a commonly used electronic form.

The right to obtain a copy of Your Personal Data shall not infringe upon the rights and freedoms of others.

### **9.2. Right to rectification**

You are entitled to require Us to rectify any inaccurate Personal Data concerning You as soon as possible. You are also entitled to have incomplete Personal Data completed. This includes the provision of a supplementary declaration.

### **9.3. Right to erasure**

You are entitled to require Us to erase Your Personal Data as soon as possible when one of the following applies:

- The Personal Data is no longer necessary for the purposes for which it was collected or otherwise processed by Us;
- You withdraw Your consent to the processing of Your Personal Data and there is no other legal basis for the processing;
- You exercise Your right to object under the conditions set out below and there is no compelling, legitimate reason for the processing;
- The Personal Data has been processed unlawfully;
- The Personal Data must be erased in order to comply with a legal obligation;
- The Personal Data was collected from a minor.

#### **9.4. Right to restriction**

You are entitled to require Us to restrict the processing of Your Personal Data when one of the following applies:

- We verify the accuracy of the Personal Data after You challenge its accuracy,
- The processing is unlawful and You object to the erasure of the Personal Data and demand instead the restriction of its use;
- We no longer need the Personal Data for the purposes of processing but it is still necessary for You to establish, exercise or defend your rights in a court of law;
- You object to the processing under the conditions set out below and We verify whether the legitimate reasons pursued prevail over the reasons that You have alleged.

#### **9.5. Right to data portability**

You are entitled to receive from Us the Personal Data concerning You, in an organized, commonly used and machine-readable format when:

- The Data Processing is based on consent, or on a contract and
- The Processing is carried out using automated processes.

When You exercise Your right to portability You have the right to have the Personal Data transferred directly by a data controller that You will designate, when this is technically possible.

The right to portability of Personal Data must not infringe on the rights and freedoms of others.

#### **9.6. Right to object**

As stated in the preamble of this Privacy Policy, You have the right to object at any time to the processing of Your Personal Data for marketing purposes, including profiling insofar as it relates to such marketing.

To do this, We inform You of the various applicable procedures in paragraph 11 below.

If You wish to object to the processing of Your Personal Data for which a button has not been provided, You can always exercise Your right to object under the conditions of paragraph 10 below.

#### **9.7. Post-mortem guidelines**

You may provide Us with guidelines regarding the storage, erasure and disclosure of Your Personal Data after Your death. These guidelines may also be registered with "*a certified trusted digital third party*". These guidelines, or "*digital will*", may designate a person to carry them out; otherwise, Your heirs will be designated.

In any case, You may indicate to Us, at any time, that You do not wish for Your Personal Data to be passed on to a third party in the event of Your death.

## 10. Exercising Your Rights

In accordance with this Privacy Policy, the Media that You have visited and on which You have accepted the storage and reading of Trackers offer simple opt-out mechanisms to allow You to withdraw Your consent as easily as You gave it.

In addition, You will find, in paragraph 11, a link to each of our Partners' procedures allowing You to object to the processing of Your Personal Data for advertising purposes.

We invite You to prioritize these procedures if You wish to object to the processing of Your Personal Data for advertising purposes.

However, if You are not satisfied with these procedures, in order to exercise Your Specific Rights, and/or, if applicable, to obtain a verbal copy of this Privacy Policy, You may send Your request by email or post to Our Data Protection Officer, whose contact information is as follows:

In order to assert Your Specific Rights, We kindly ask You to provide proof of Your identity, mentioning Your surname, first name, email address (hereafter your "**Identifying Data**").

In particular, as we do not collect Your directly-identifiable Personal Data during our advertising operations (see paragraph 2), we may ask you for additional information in order to respond to your request, for example one of your technical identifiers such as: your IP address, your Device ID, your Tracker number or your advertising identifier, and will assist you in this regard.

A response will be sent to You within a maximum of one (1) month following the date of receipt of Your request.

If necessary, this period may be extended by two (2) months, depending on the complexity and/or the number of requests, which we will inform You of.

In the event of a request for the deletion of Your Personal Data and/or in the event that You exercise Your right to request the erasure of Your Personal Data, We may, however, keep this data in the form of intermediate archiving in accordance with CNIL Deliberation No. 2005-213 of 11 October 2005, for the duration necessary to meet Our legal, accounting and tax obligations.

You can, at any time, file a complaint with the competent supervisory authority (in France, the CNIL: [www.cnil.fr](http://www.cnil.fr)).

## 11. Objecting to Trackers

As indicated in paragraph 5.1, You are informed, during Your first visit to a Medium, that You can choose to object to the storage of Trackers on your Terminal, in particular by configuring Your Internet browser to do so or by exercising Your choices on the page of the Medium that the Publisher has made available for this purpose. You can, at any time, return to this dedicated page and thus modify Your consent.
